Dear brothers and sisters of the service department of the USA branch of Jehovah's Witnesses:

In this brief introductory letter I would like to explain the reasons and objectives of the printed documentation that I sent you in this package.

The Bible tells us:

*Galatians 6:1*

*Brothers, even if a man takes a false step before he is aware of it, you who have spiritual qualifications try to readjust such a man in a spirit of mildness. But keep an eye on yourself, for fear you too may be tempted.*

This makes it clear to us that when someone makes a serious mistake, we must point it out to them out of love and with love.

Who is subject to this advice? Only the publishers of the congregation?

Of course not, every brother should receive this kind of love regardless of his privileges or prominence in the congregation.

For example, we know that Peter was an apostle appointed by Jesus Christ himself, but the letter to the Galatians shows us that Paul corrected Peter in front of everyone for his public sin. (Galatians 2:11-14)

Any of us understands that the things written in the Bible are written there to teach us to do what is right. (2 Timothy 3:16,17) So that example is instructive for all of us.

What should be done if a brother who is part of the Bethel family commits a serious sin?

The book "SHEPHERD THE FLOCK OF GOD" tells about the sins committed by Bethelites at point 12:43:

---

THOSE HAVING CERTAIN PRIVILEGES OF SERVICE

---

*43. If someone in the congregation who has one of the following service privileges is accused of or confesses to serious wrongdoing, two elders with knowledge of the circumstances should immediately contact the **Service Department** for direction on handling the matter. These privileges would include serving as a Bethel family member, a temporary volunteer at Bethel, a construction servant, a construction volunteer, a full-time or part-time or occasional commuter to Bethel, a full-time or part-time construction commuter, a remote servant or volunteer, a Bethel consultant, a field missionary, a temporary special pioneer, a special pioneer, an Assembly Hall servant, or a Bible school facility servant*

---

So the people in charge of giving guidance and dealing with the sins of Bethel brothers are the members of the service department. That is why I am sending this documentation to you.

Who is the one who has committed the alleged sin to which I am referring?

The entire governing body.

Before you dismiss this letter as a joke in bad taste, I would like to tell you that I am unfortunately very serious. You have in the attached form the unquestionable evidence of this. The proof is just a few inches away from your hands.

The sins have to do with the unbiblical stance taken during the Covid-19 pandemic by the Governing Body that made our brothers believe that Jehovah wanted them to be vaccinated.

I am not suggesting that I am advocating non-vaccination. Everyone has the right to make their own decision and it must be respected as the word of God commands us. I believe in neutrality with respect to medical treatments, which is the biblical position.

The problem is that the Governing Body abandoned neutrality and promoted an experimental treatment that has sickened and killed many of our brothers.

Since brothers have died, we are talking about **“Homicide”** as shown in the book “PASTOREEN”.

Please don't misunderstand me. I'm not saying there was any bad intention on the part of the Governing Body, because if I did that I would be judging and that is a sin. They probably believed that what they recommended was the best.

But we all know, as the book “Pastoreen” says, that when there is suspicion of negligence leading to homicide, the matter must be investigated regardless of the intentions of the accused. Homicide is not defined by intentions.

The Book “*SHEPHERD*” section 12:38 says

---

*38. Manslaughter: Aside from deliberate murder, bloodguilt may be incurred if a person causes loss of life through carelessness or because of violating a traffic law or other safety law of Caesar. The elders should investigate and if warranted appoint a judicial committee to hear the matter. The committee should base its decision on clearly established facts, not simply on a decision that may have been made by secular authorities. —Deut. 22:8; w06 9/15 p. 30*

Causing **“death by negligence”** is what the Governing Body did and is proven in the attached form.

This serious accusation alone merits an investigation that is even more urgent when the accused are brothers with responsibilities, since the scriptures say that they must be **“free from accusation”** (1 Timothy 3:2, Titus 1:6).

In the attached letter you will find all the evidence that proves this accusation in detail and many other things that make it absolutely clear that this must be addressed urgently. The right thing to do is for a judicial committee of trained brothers in whom the spirit of God undeniably acts to address all this.

If I could discuss this personally with the Governing Body I would tell them directly. But since I live on the other side of the world, the evidence contained in the letter is addressed directly to them, as if I were speaking face to face in a conversation.

But as you will notice, it is not a private letter but a public and open one. Why is this so?

In the letter you will find several reasons, but essentially it is because the seriousness of the matter forces me to expose all this publicly.

Not only that, this letter has already begun to be distributed among all the brothers and I will make sure that everyone who wishes to read it has access to it in a language they can understand.

Dear brothers, this is serious and I hope you understand that immediate action is required due to the gravity of the sins committed.

I understand that you have many tasks and obligations that require your time and attention, but the Bible reminds us to **“make sure of the more important things”** (Philippians 1:10).

Today there is nothing more important among your duties than to attend to this, because as I have told you, there are already many brothers reading this letter and many more will do so shortly. I will not stop until everyone knows about this.

Everything stated here must reach the Governing Body and they must be informed immediately.

If the material I have sent you is destroyed or stored forever in a dusty drawer, you will be held responsible for not paying attention to the injustice committed.

I am freed from **“blood guilt”** by having informed you about this and the responsibility falls from now on on you. (Acts 20:26,27)
